2025 Youth Scholarship Doubles & Singles Handicap Tournament - Rules

1. ELIGIBILITY

- a. Tournament is open to all youth Greater Ozaukee Washington Bowling Association (GROWBA) active youth league members or sanctioned youth bowlers that live in either Ozaukee or Washington County.
- b. Unless otherwise specified, all USBC rules will apply.

2. ENTERING AVERAGE

- a. All bowlers will enter using their highest current USBC Youth league average, minimum of 9 games as of January 1, 2025.
- b. If no current league average with 9+ games, use last year's USBC Youth league average, minimum 9 games.
- c. If no average is otherwise available, bowler will compete with a 200 average.
- d. Tournament averages can be updated or reported at the time of the event. We recognize that averages at the time of entry are likely to change. We want to encourage early entry and not have participants being too worried about their official average.

3. TOURNAMENT FORMAT

- a. Both Doubles and Singles events will be a 3-game, total pinfall, with handicap, format.
- b. The Doubles event is bowled first, followed immediately by the Singles event.
- c. All six games will be bowled on the same pair of lanes.
- d. If you do not have a Doubles partner, we will attempt to pair you up with another bowler without a Doubles partner.
- e. Bowlers who only compete in the Singles event will start when the Doubles event ends, and no practice will be permitted.
- f. Handicap for each bowler will be 90% of 200. Bowlers with average 200+ receive 0 handicap.

4. ENTRY FEES

- a. All entries must be accompanied by the full entry fee to guarantee a spot in the tournament.
- b. Fees can only be made by check or cash. Electronic or credit card payments are not available at this time.
- c. \$15 per event entry fee consists of \$8 for lineage and \$7 for the Scholarship pool.
- d. \$1500 added to scholarship pool by GROWBA.
- e. Approximately 1 in 4 bowlers for each event will receive scholarship money via SMART funds.

5. OTHER TOURNAMENT INFORMTION

- a. All bowlers will compete in a single division.
- b. First place finishers in each event will also receive a medal for their achievement.
- c. Maximum game score may not exceed 300.
- d. Maximum individual series score may not exceed 900.
